Per the Town of Paris Site Plan Review Ordinance, Article 5. "The Board shall review the application for conformance with the following performance standards and make findings that each has been met prior to the approval of a Final Plan. In all instances the burden of proof shall be upon the applicant to present adequate information to indicate all performance standards and statutory criteria for approval have been or will be met."

Per the Town of Paris Site Plan Review Ordinance, Article 2.3.E. "All Site Plan Development applications approved by the Planning Board shall be effective for a period of two (2) years after the date of approval unless substantial construction there under has commenced. If work is not completed within three (3) years from the date of approval, the permit lapses and a new application must be made and approved. There will be no additional charge for application review provided application is unchanged."

Per the Town of Paris Site Plan Review Ordinance, Article 2.3.H. "If the services of outside consulting engineers or other professions are required by the Board to assist in the review of the application, or the amount or conditions of any performance guarantee that may be required, the Board shall notify the applicant of the nature of such services. The cost of such services shall be paid by the applicant and evidence of such payment shall be provided to the Board before the final plan is approved."
